

## Pravila uporabe objekta PIRATE MONKEY za uporabnike:

1. Pred uporabo **PIRATE MONKEY** se mora vsak udeleženec seznaniti s pravili uporabe. Pred uporabo s podpisom potrjuje, da je z njimi seznanjen in se z njimi strinja. Udeležence do 15 let starosti mora s temi pravili seznaniti polnoletna oseba in to s svojim podpisom potrditi (potrebna je navedba imena in priimka odgovorne osebe in udeležencev ter kontaktni podatki). Udeleženec s podpisom potrjuje, da sodeluje v aktivnostih **PIRATE MONKEY** na lastno odgovornost.
2. Uporaba **PIRATE MONKEY** je povezana s tveganji in se izvaja na lastno odgovornost udeležencev.
3. **PIRATE MONKEY** je primeren za udeležence starejše od 6 let, ki nimajo psihofizičnih težav povezanih z višino in bi uporaba **PIRATE MONKEY** zanje ali za druge predstavljala zdravstveno ali kakršno koli drugo nevarnost ali tveganje. Otroci pod 15. letom starosti lahko uporabljajo **PIRATE MONKEY** le v spremstvu odgovorne polnoletne osebe.
4. Kajenje med uporabo parka oziroma med nošenjem varnostne opreme ni dovoljeno.
5. Uporaba **PIRATE MONKEY** izven odpiralnega časa je strogo prepovedana!

Glede uporabe posameznih poligonov, ki so različnih težavnostnih stopenj, veljajo dodatne zahteve:

Oznaka poti	Zahtevana starost/višina
Šolski poligon	vsi udeleženci
Plezalna stena	vsi udeleženci
Zipline	udeleženci od 8 let oziroma min. teža 30 kg, min višina 140 cm, max. teža 130 kg
Freefall Jump	Udeleženci od 8 let oziroma min. višina 150 cm, max. teža 130 kg

6. Drobni predmetov, kot so npr. nakit, mobilni telefoni, kamere, ipd., pri uporabi **PIRATE MONKEY** ni dovoljeno imeti pri sebi, saj lahko predstavljajo nevarnost za udeleženca samega in druge osebe.
7. Vsak udeleženec se mora udeležiti pojasnil varnostnih navodil, ki so sestavljene iz teoretičnega in praktičnega dela. Vsa navodila trenerja/ inštruktorja oz. organizatorja so zavezujoča in se jih je obvezno potrebno držati. Pri kršitvi se lahko od udeleženca zahteva, da zapusti **PIRATE MONKEY**.

8. Varnostna oprema, ki jo prejmejo udeleženci in je sestavljena iz varnostnega pasu, karabinov (vponk) in varnostnih čelad in se med uporabo **PIRATE MONKEY** ne sme odložiti ali prenesti drugim osebam. Varnostna oprema se mora uporabljati v skladu z navodili inštruktorja oz. organizatorja. Celotna varnostna oprema se mora po uporabi **PIRATE MONKEY** vrniti. Varnostni karabini (vponke) morajo biti vedno obešeni na varnostno zanko plezalnega pasu. V primeru dvoma mora obiskovalec nemudoma poklicati inštruktorja za nadaljna pojasnila.
9. Vsako vajo lahko izvaja istočasno maksimalno ena oseba. Na platformah se lahko istočasno nahajata maksimalno dve osebi. Uporaba poligonov je dovoljena le v skladu z določili iz točke 3.
10. Uporaba **PIRATE MONKEY** pod vplivom alkohola, mamil ali drugih sredstev, ki zmanjšujejo psihofizične sposobnosti ni dovoljena.



## Instructions and rules for PIRATE MONKEY

1. Before first visit of **PIRATE MONKEY** adventure each participant must read this instructions and rules. Adults or professional personnel must present this instructions and rules to visitors younger than 15 years and sign it for them (name, surname and contact number of the adult must be written on it). Visitor with signature confirms that she/he has read the instructions and rules and agrees that use of **PIRATE MONKEY** is on her/his own responsibility.
2. Visitors are aware to accept some risks related with climbing activities when using **PIRATE MONKEY** adventure and are fully responsible for their own safety. For company's responsibility read paragraph 7.
3. **PIRATE MONKEY** adventure is appropriate for visitors older than 6 years, who do not have any physical and/or psychological problems with height and any other health issues, which may be risky or dangerous. Children under 15 years are allowed to visit **PIRATE MONKEY** adventure only accompanied with adult or professional personnel.

For use of specific adventures requires some additional requirements:

Climbing wall	All participants
Zipline	All participants from 8 yrs., min. weight 30 kg, min height 140 cm, max. weight 130 kg
Freefall Jump	All participants from 8 yrs., min. weight 30 kg, min height 150 cm, max. weight 130 kg

4. Small objects, like: mobile phones, cameras, jewelry, sun glasses, etc. are not allowed at any time during the use in the High Ropes Course Hofstade, since they can present danger for you or other visitors.
5. Before using **PIRATE MONKEY** adventure each visitor must take a short course (theoretical and practical) on the ground for the proper and safe use of the personal safety equipment, which ensure safety. All safety precautions are obligatory and must be consider during the use. In case of violation visitor can be requested to leave **PIRATE MONKEY** adventure. In case of violation company KOREN SPORTS does not take any responsibility and/or compensation claims.
6. Safety gear, which every visitor gets, must not be taken off during the visit and/or climbing at **PIRATE MONKEY**. Safety gear must be used as instructed. All parts of safety gear must be undamaged and returned immediately after use.
7. Company KOREN SPORTS is responsible in context by law for personal damage. Company is responsible only for material damage and property in case of instructor's or owner's carelessness.
8. Enter to the main/central tower is allowed only by supervision of professional personnel.
9. Organizer can request visitor to leave **PIRATE MONKEY** adventure in case of violation of this rules. Organizer can stop the use in case of safety precautions (fire, strong wind, thunderstorm, etc.). In this case entry fee is not refunded. Entry fee is also not refunded in case of voluntary exit of **PIRATE MONKEY** adventure.
10. Use of **PIRATE MONKEY** adventure is not allowed when consuming alcoholic drinks and/or drugs. Smoking is not allowed during the use of personal safety equipment and/or during climbing.
